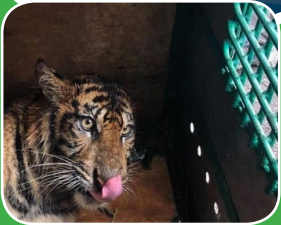

The Role of Apex Predator in the Sumatra's Rain Forest Ecosystem

The Sumatran tiger is the apex predator in the food chain of Sumatra's forest ecosystem. Tigers maintain the balance between prey species and the rest of the system, they control prey populations and provide ecological stability. Tigers have a low population and are vulnerable to hunting, either hunting for predators themselves or hunting for prey animals.

The scarcity of the prey animal can result an imminent threat to the predator's food source, as well as the extinction of apex predators (tiger, leopard or other species at the top of the food chain) may cause overpopulation of the species below apex predator's rank in the food chain. The excessive hunting of any species will cause instability in the entire ecosystem. In principle, apex predators increase the stability of the ecosystem by properly balancing their prey populations.



May 20, 2020

August 24, 2020
A team from North Sumatra Natural Resources Conservation dispatched to the area and evacuated the young tigress to the Barumon Nagari Wildlife Sanctuary, Batu Nanggar Village, Aek Godang, Batang Onang District, North Padang Lawas Regency. The tigress was at good, aggressive and healthy condition at the time she got caught.



Three months treated and taken care in the sanctuary, the tigress reached its good health condition. Hence, it was the perfect time to release it into its natural habitat.

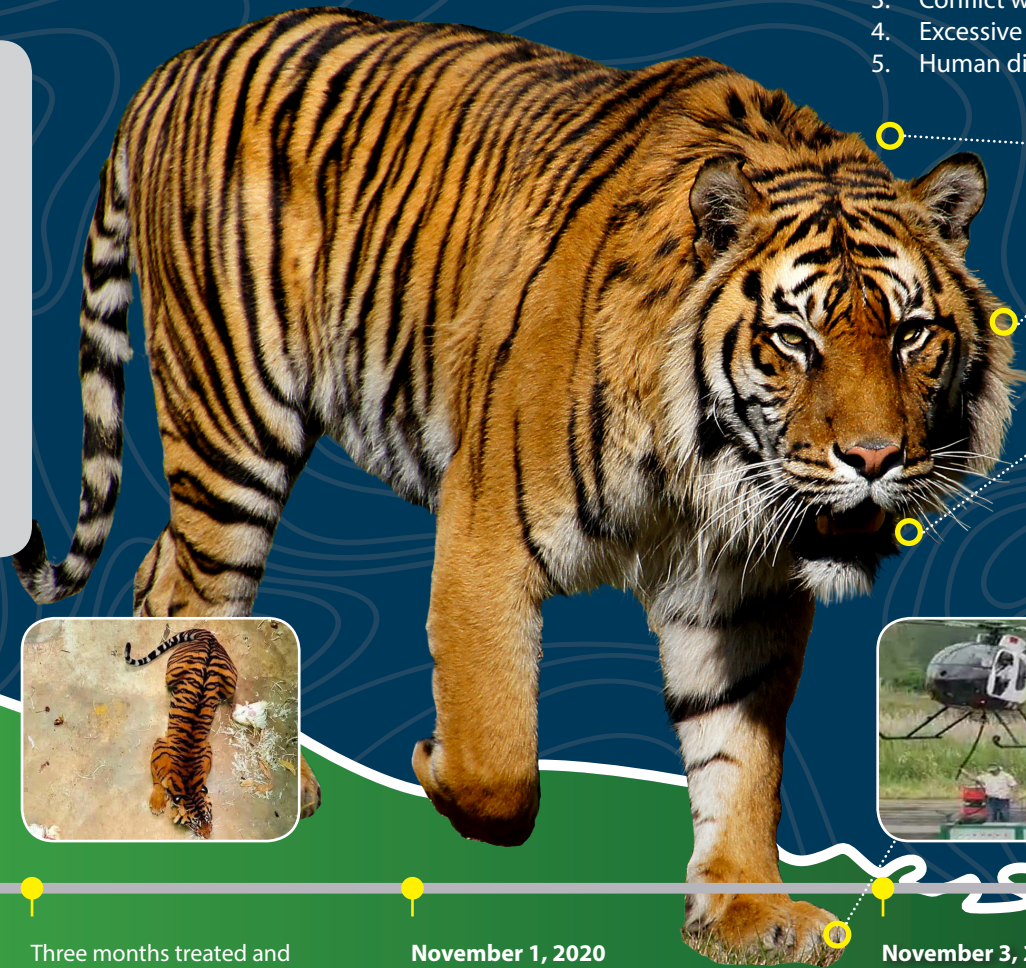
November 1, 2020
Guarded by a team from North Sumatra Natural Resources Conservation and a medical team, Sri Nabilla' started the long journey to her new home, 500 km away to the north. It is the Leuser National Park area, Gayo Lues, Aceh.

IMINENT THREATS FOR SUMATRAN TIGER

1. Poaching. The trade of tiger's body parts or intact tiger body.
2. Habitat loss. The expansion of oil palm plantations was the primary driver of Sumatran tiger habitat.
3. Conflict with human
4. Excessive hunts of its prey species
5. Human direct hunt on tiger

2. The fur of the Sumatran Tiger is the darkest and has the thickest and longest mane among other tigers in the world.
3. Sumatran Tiger loves durian.
